**ITEM#1**

To consider a stipulation amendment for Mr. Rabah Mouas who represents 3778 Canton Road, LLC regarding rezoning application Z-74 of 2001 (Robert E. Hightower), for property located at the northeast intersection of Canton Road and Centerview Drive in Land Lots 299 and 300 of the 16<sup>th</sup> District.
