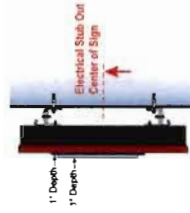

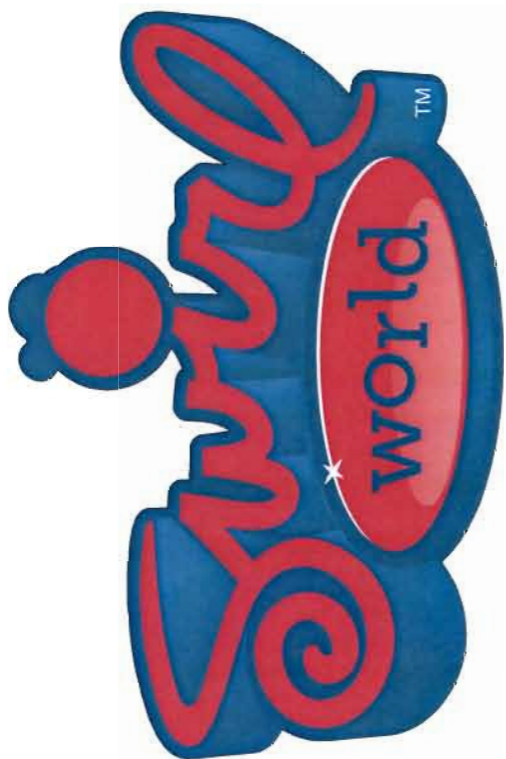


Illuminated Wall Display

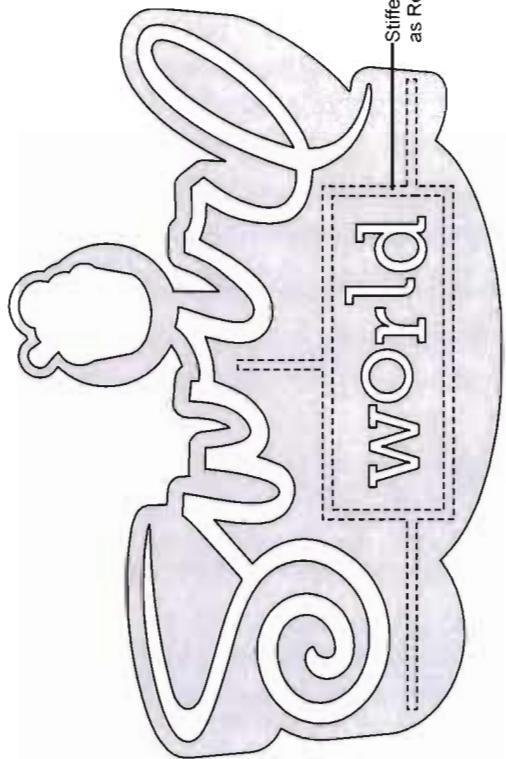


## Swirl World Sign (D) Graphic & Face Layout

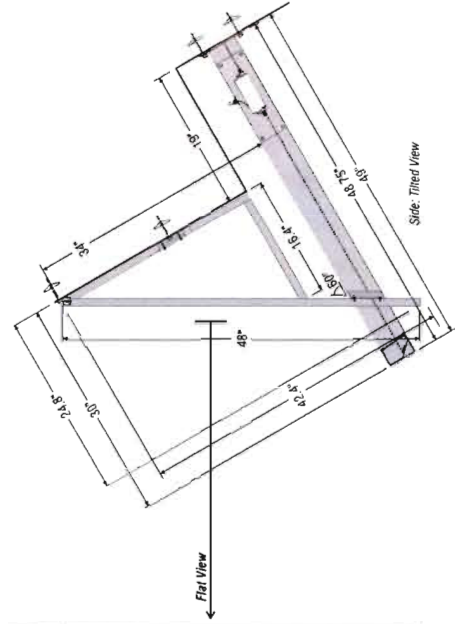
Sheet Aluminum Detail - Front Flat View

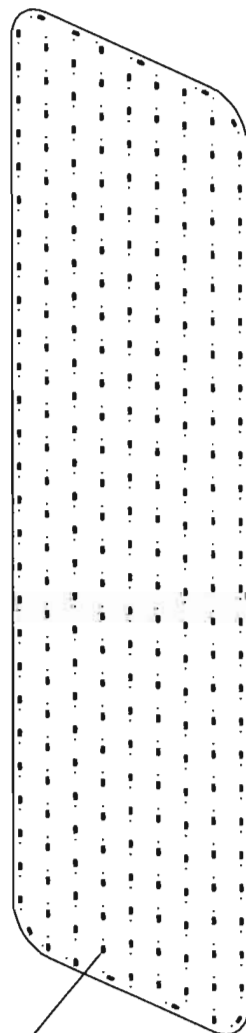

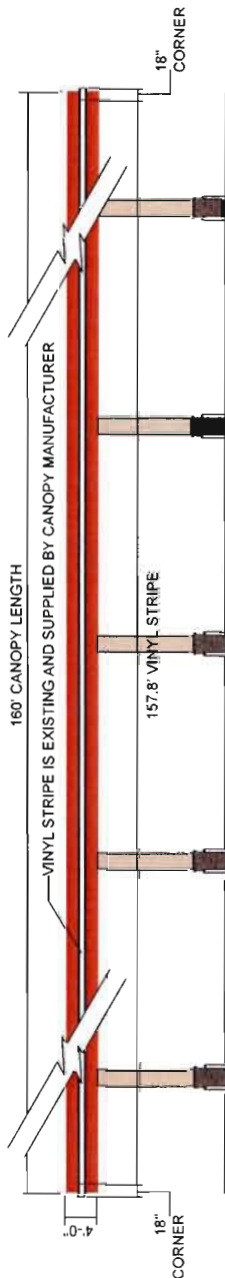


GAS CANOPY FRONT ELEVATION

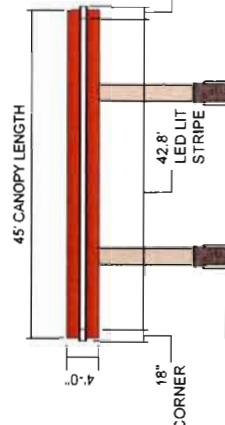


RIGHT SIDE VIEW - RED CANOPY

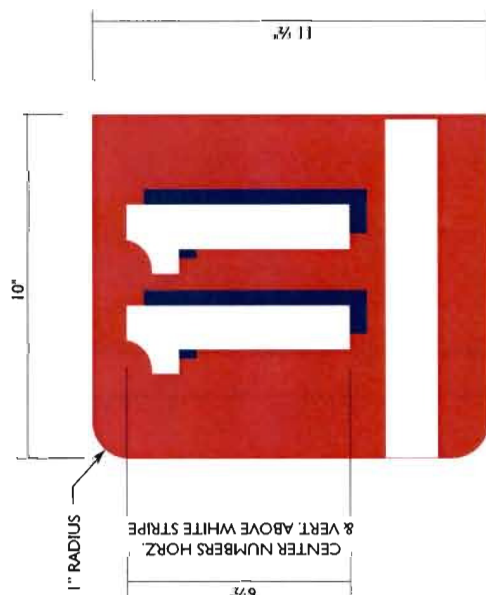
