If the Planning Commission cannot or does not grant the Applicant permission to withdraw, then we withdraw our applicant without permission, which we understand will be deemed a rejected application.


As indicated in Mr. Campbell's email of yesterday, we are submitting this letter to Mr. Pederson with the notarized signatures of the Applicant and me.
