PURPOSE

To consider a reduction of minimum public road frontage for Nestor F. Mendoza for property located on the north side of Stone Harbor Parkway, east of Hicks Road, in Land Lot 21 of the 17th District (788 Stone Harbor Parkway). *(Continued by Staff until the February 19, 2019 hearing)*

BACKGROUND

The Board of Commissioners considers all reductions to minimum public road frontage pursuant to a code amendment to Sec. 134-271(7)(a) adopted on February 27, 2018. The subject property is zoned R-20 which requires 75' of public road frontage. The applicant has 66' of frontage for this lot. This lot was platted with 100' of public road frontage in 1974. Based on the survey submitted along with plat research, Staff believes there may have been a surveying error in 1974. Approval of this request would allow the applicant to build one house on this lot. All other zoning criteria would be met.

STAFF COMMENTS

Stormwater Management: Subject to Stormwater Management approval of site grading plan.

RECOMMENDATION

The Board of Commissioners conduct a Public Hearing and consider the proposed reduction of minimum public road frontage.
